Brief Description of Institution

Founded in 1991, YunTech is a practice-oriented university guided by the motto of Sincerity, Respect, Perseverance, and Innovation. With strengths in industry-academia integration and innovative design, it aims to become a responsible smart university driven by technological research and innovative services. YunTech enhances learning and employability through smart technologies, a dual-track system, and industry-oriented PBL. It has five colleges and about 11,000 students. Its 406 full-time faculty members provide a strong foundation: over 97% are assistant professors or above, 92% hold doctoral degrees, 91.7% have practical experience, and over 70% engage in industry-academia collaboration. YunTech pursues diversified learning, industry-oriented research and innovation, sustainable resources, global visibility, and agile decision-making to strengthen talent development, social contribution, and international visibility toward Asia's top 100 and the world's top 500 universities.

-D1.1.3 Of which was derived from research activities

refers to the income generated by the institution from research activities and related support activities, including governmental research grants, industry-sponsored research funding, revenues from research contracts, technical service fees, and other research-related income.

-D1.1.4 Of which was derived from donations and endowments

refers to funds received by the institution or institutional endowment from individuals, corporations, foundations, alumni organizations, or other external entities, with no restrictions or only limited restrictions on their use. This excludes revenues from investments of endowment funds.

-D1.1.5 Of which was derived from self-operating activities and investments

refers to the revenues generated by the institution through self-operating activities, service provision, investments (including investments of endowment funds), and the management or utilization of institutional assets.
